Home Legend LLC's 10mm Piano Finish Laminate Flooring comes with a Manufacturer's Limited Fifty Year Residential Wear Warranty. The warranty applies to original purchaser of the flooring; it is not transferrable.

Home Legend LLC's 10mm Piano Finish Laminate Flooring Limited Fifty Year Residential Wear Warranty is subject to the following conditions:

The flooring must be installed properly in accordance with the manufacturer's installation instructions.

The flooring must be used only indoors in dry, climate-controlled residential areas. This limited warranty does not apply if used in any commercial setting.

The flooring must be maintained in accordance with included care and maintenance instructions.

Damage must not have occurred as a result of improper or inadequate maintenance or accidents, such as damage caused by scratching, impact or cutting.

Damage resulting from the use of a jet mop, spray mop, or similar wet mop with flooring is not covered by this limited warranty.

Damage caused by gloss or sheen reduction is not surface wear and is not covered.

This limited warranty does not apply to damage caused by water or moisture on the floor, in the subfloor or underneath the floor, including, but not limited to, water damage caused by flooding, standing water (water that remains on the floor longer than 30 minutes), subfloor hydrostatic pressure (water or moisture under the floor that is transmitted to the surface through exerted pressure) leaking pipes, household mechanical failures, appliance leaks, pet urine, or conditions that result in water or moisture being below the floor.

This limited warranty does not apply to flooring installed on a concrete subfloor unless a non-recycled (100% virgin resin) 6-mil. Polyethylene film vapor barrier with a density of .92 lbs./cubic ft. and a thickness tolerance of +/- 10% is installed over the concrete subfloor that emits a water vapor no greater than 5 lbs. per 1000 sq. ft. within 24 hours.

This limited warranty applies only to defects inherent to the material supplied. Defects inherent to the material supplied are defined as defects that were not visible before or during installation of the flooring. If there is a visible defect in the flooring material, the flooring material should not be installed, and should instead be returned as damaged material.

Home Legend, LLC's Responsibility:

If Home Legend, LLC accepts a claim under this limited warranty, Home Legend will repair or replace, at its option, the Home Legend 8mm Piano Finish Laminate flooring material only. If Home Legend, LLC, in its sole discretion, determines that such repair or replacement is not reasonably achievable, Home Legend, LLC may choose to refund the purchase price of the affected flooring material. If the Home Legend 8mm Piano Finish Laminate design for which a claim is made is no longer available, Home Legend, LLC will replace the affected floor materials with another customer-approved design of equal or greater value at Home Legend LLC's discretion. Upon approval of a warranty claim, Home Legend, LLC will provide instructions on the manner in which to proceed in order to have your flooring repaired or replaced. Comply with such instructions within ninety (90) days after the claim is approved or your rights under the limited warranty will be deemed waived. The above remedies are the sole and exclusive remedies for claims on this Home Legend 8mm Piano Finish Laminate product. These limited warranties give you specific legal rights, and you may also have other rights which vary from State to State.
